PAYMENT FOR SALES

PAAC will pay the artist 50% of consigned retail price on all sold artworks within 30 days of the close of the show

ENTRY REQUIREMENTS

ELIGIBILITY: Open to all PAAC Members working in all two dimensional media.(Excluding photography & Digital Art) Open to all original paintings completed "en plein air" from January 1, 2007 to present that have not been exhibited in previous PAAC shows. Paintings **MUST** be available for sale. Neither dimension of painting image may exceed 30 inches. Work done under the guidance of an instructor is not eligible.

Work must be professionally framed and ready to hang. No saw-tooth hangers. PAAC is not responsible for breakage or replacement if work is framed under glass.

ENTRY

Entry by Slide submission: Slides should be 35mm with standard 2"x2" slide mounts; no glass or odd-sized mounts. Name of artist, title, size, medium and price must be clearly marked on the front of each slide, with the top right of the image indicated with a red dot. Slides without this full information will not be accepted. Up to five slides may be submitted. Do not paperclip your slide to your entry.

Entry by Digital submission: Image Specifications: Submit jpg images set at 300dpi x 4" in the largest dimension (1200 pixels).

Title your image files on your disc as follow:

FEES

Fees per entry: First 3 slides @ \$35.00, up to 2 additional slides @ \$10.00 each
Entry Fee is non-refundable and must accompany entry form and slides/CD. Checks should be payable to Plein Air Artists Colorado. Enclose a self-addressed stamped #10 envelope for results of jury notification. Slides and digital images will not be returned. PAAC will retain accepted slides/images for future reference and for advertising purposes. All submissions will be viewed by the Jury of Acceptance; awards will be determined by the Awards Juror. Entries must be RECEIVED no later than April 15, 2008.
